Leadership vs. Management

While in graduate school I had the opportunity to study with Professor Jean Lipman-Blumen, a first rate scholar

and author of such prodigious books as <u>Hot Groups</u>, <u>The Art of Followership</u>, <u>The Allure of Toxic Leaders</u>, and <u>Connective Leadership</u>. I took several courses from her, the first being titled, "Leaders and Managers, E'er the Twain Shall Meet." The course was instructive for it brought me face to face with the dynamics involved in these two disciplines -- leadership and management.

From this I have learned that both disciplines are important, but they are not the same. Stephen Covey and Warren Bennis, quoting Peter Drucker, popularized the quip, "Managers do things right; leaders do the right

things." That's clever, and perhaps even a bit wise, but that is merely a starting point.

Most managers who are effective as managers have a tough time being effective leaders. The black hole of managing seems to suck them in and they find themselves jumping from one crises to another, from one



project to another, from one demanding, deadline-driven task to another.

Leadership, by contrast, is a bit more cerebral. It involves vision, empowerment, rallying the troops to march towards a desired future state, etc. I consider real leadership to be far more esoteric than the day-to-day activities of the effective manager.

And while both are very important, most people (especially in business, law, law enforcement, and education) tend to default to management activities and not leadership endeavors.

Knowing this, allow me to spell out a simple antidote to the swarming nature of management tasks which tend to push out into the cold the leadership tasks that never seem to get the attention they deserve.

Since management seems to be the norm, *manage* your leadership practices. Do this by dedicating a portion of your day or week to the art and practice of leadership. Make that time commitment a sacred trust that is inviolate and untouchable. Do not allow other pressing matters to creep into that time which you have earmarked for leadership.

Make the study of leadership a part of that time, albeit a smaller portion of that time. Read great books on leadership (you can get a glimpse of some of my favorites by clicking here.) You can also study the lives of some of the great leaders of the past (ex. Churchill, Gandhi, Reagan, Martin Luther King, Leonardo da Vinci, George C. Marshall, etc). You can buy the books, or you can get them from the public library in hard copy or audio formats.

In addition to reading about leaders and leadership, spend some of that time thinking like a leader (as opposed to a manager.) What direction do you wish to move in? What grandiose goals could you set? What innovations could you pursue?

Once you have some powerfully audacious goals before you, your management hat will come in handy as you allocate resources and time and people to bring such goals to fruition.

Many years ago the television show Saturday Night Live ran a recurring skit featuring a character named *Church Lady* played by Dana Carvey. The skits were always rather funny and the Church Lady character remains one of the more memorable characters from the television show.
